Hospitals & Institutions

Hello everyone, I'm an addict named Terry. The H&I subcommittee is doing very well. We've received questions from previous area meetings. Brandon T serves as the vice chair of H&I, and Danielle is our secretary. There was another request for the total number of facilities we're currently involved with. At present, we're active in 8 facilities, and we're working on two new ones. Our meeting hours have also increased. Previously, we were working on a 1-hour coach program, but now we hold two meetings each week—on Mondays and Wednesdays. Additionally, we're transitioning from Friday to Monday for the Woodhaven facility. Our current attendance includes Montgomery County Jail Gateway, the men's homeless shelter, Woodhaven (Wednesday), The Women's program at Woodhaven (Friday, soon moving to Monday), The Monday night coach program (two meetings) The separate Wednesday night coach meeting, Nova House program, DCI. We're also in the process of adding the women's homeless shelter to our list. Additionally, we've resubmitted paperwork for the MonDay program, which will take approximately 2 to 3 months. Overall, this means we've achieved a 150 percent increase in carrying the message to facilities within the last 8 months.

Hello everyone! My name is Twitch, and I am the phone line chair. To start off, we had a training and learning day on April 20th during which we welcomed two new phone line members—thank goodness! One of them will serve as the alternate chair for this committee, so we're making progress in improving our phone line services. Now, let's dive into my report. This month, we received a total of 25 calls. Our PBX system, which we rely on, has undergone a complete format change. After some detective work, I determined that these 25 calls occurred within this month, resulting in a total talk time of 34 minutes. Interestingly, there were no outgoing calls. I'll be reaching out to verify this because sometimes our volunteers might miss a call but then check online to find out who it was and where it came from. However, this month, there were no such outgoing calls—a bit unusual, don't you think? That's all I have for my report!

RCM

Hello, family! I'm an addict named Gary. The regional meeting was held at Eastgate and started approximately at 10:00 a.m. The call to order was made by the chairperson. The readings of the 12 Traditions were done by Lenore P., and the 12 Concepts were read by Ricky. The service prayer was recited by all members present. The 'Just for Today' daily meditation was read by Mark. The roll call included all administrative body members, and everyone was present except for the regional delegate alternate, the secretary, the hospitals and institutions chair, and the 12 Traditions Retreat chair. The OOCNA Advisory chair positions are open, including public relations and vice webmaster roles. During the roll call of RCMS, 11 out of 16 members were present. Administrative business was discussed, but there was no old business. The meeting also involved a discussion about creating an ad hoc committee to address tax filing and statutory agent responsibilities. The Regional Delegate meeting began around 2:59 p.m. with a moment of silence followed by The Serenity Prayer. Conversations during this meeting focused on motions to establish the ad hoc committee and appoint someone as the statutory agent. Round-robin discussions centered on how to engage more members in service. Our area has been actively working to fill all positions and update policies. Another area shared their experience with conducting surveys and providing online training for open positions. They've made significant progress this quarter, with all positions filled and increased participation in area meetings. The meeting concluded around 4:45 p.m. with love and service. Literature

Hey family, my name is Eric. I'm an addict. The literature office report is as follows: We had a beginning balance of **\$7,334.50** for literature/merchandise. I'll repeat that balance: **\$7,334.50**. Cash on hand is **\$240.80**, and money in the bank is **\$495**. There are no supplies expenses listed. We paid out **\$130** for rent and received no donations. We have two pending amounts: one for **\$73.37** and another for **\$136.44**. The total revenue for the literature office is **\$8,069.30**. I received a call requesting information about the bank institution the literature office uses and a bank statement. It came to my attention that all statements go to the post office box, and the treasurer receives them. If I need to do more research, she mentioned she can obtain them from the bank if necessary. The bank we use is

Fifth Third Bank, but the treasurer does not receive monthly statements. She was under the impression that they were sent to the post office. If they're not going there, I'll coordinate with her to physically retrieve a statement and proceed accordingly. I'll also inform Sharon, the chairperson, about the situation so that we can ensure the statements reach their intended destination.

Convention

I'm an addict named Brian. Our meeting was held last Saturday. There was a mix-up; the time was supposed to be at 1:00 p.m. At the beginning of the meeting, there were only four or five people. The readings were read, and the prayer was said. We opened with a service prayer, the 12 traditions, and the 12 Concepts. Minutes from the previous month's meeting were read by our secretary. We got into old and new business, covering topics like registration forms. That conversation carried on over the past week. Members had a concern about being cluttered. We also discussed budgets for each committee, merchandise, and items involved in registration bags. The process of making those purchases and submitting a budget was a hot topic. We also addressed the Cash App problem. As I give my report, I want to emphasize that it's essential to know the dates because the price has changed. Although the new flyer has all the new different dates, some may think it's still the last series' registration price and not turn it in until after it has gone up. We received a payment that was \$5.00 short due to this confusion. I suggested the registration committee reach out to the person involved. We also covered general topics, including our venue for fundraisers and the logistics of our actual convention. We discussed when we'll start making payments to the hotel; the first payment was made on Monday or Tuesday. I'll have that information at our next meeting and will share the monthly amount we'll be paying. Our ending balance, before the first payment, was \$4,612.75, and our beginning balance was **\$4,587.66**. As our secretary mentioned, our venue has changed. I only brought 10 flyers, and it's not the chairperson's fault; they were the first to find out about the other event. The new event location is 3520 East 3rd Street. If you can share this information, the hotels and Hospitality subcommittee brought up the idea of interim fundraisers. That's all I have for now in living service. Brian W.
