. No person shall purposely, willfully, or maliciously throw or place any glass, tacks, metal, stone, arthenware, or other substance likely to cause injury to pedestrians, animals, bicycles, automobiles, or

ther vehicles in any park or boulevard. (Section 95.11 R.C.G.O.)

. Swimming is not permitted except in designated areas. (Section 38.42 R.C.G.O.)

. Bicycles are not to be ridden on any footpaths, grass plats, or planting areas. (Section 38.44 R.C.G.O.) All vehicles shall be operated only upon park roads provided for vehicles and in accordance with State nd City law requirements for operation over streets and highways. Vehicles also shall be operated and arked in accordance with established rules, regulations, and speed limits. No unregistered motor ehicles shall be permitted within the boundaries of any City park.
